New Business

- Service Plan to move forward the LUD of Warren Committee requires: the December Financial Statement, Armia's list of costs as requested, recycling revenue estimate.
- D. Friesen spoke with C. Riddell about establishing a Dog Park for Warren. The proposed site of the old location of the Outdoor Arena was suggested. C. Riddell is in favour of this project and may have a better location than the old Outdoor Arena.
- Garbage will now be picked up weekly year-round. This will begin February 24, 2021. The Community Calendar will be updated. A notice will be sent out on the Community Facebook Page.
- High Speed Internet. There are grants being applied for by high speed internet providers. Letters of support for the project were submitted.
- LUD Boundary What are the pros and cons to expanding the boundaries? What happens if the population grows to over 1,000? Does the Village then have to become a Town? Will it be possible to remain as a LUD? It was discussed having a representative from Municipal Relations come to a meeting to discuss.
- Park N Ride C. Olson got a map of the proposed location from the Planning Development Officer. The RM owns a small portion of the proposed area. C. Olson spoke with R. Vankemanade about using the Community Center property. R. Vankemande will speak with his Board but doesn't foresee any objection. Signage will need to be purchased.
- Complaints have been received about a town business regarding a trailer being left on the roadway in Warren along with cars being parked for an extended period of time and garbage bins being left in the way of traffic. To be discussed further.
- There was discussion about the installation of the Columbariums in the Warren and Meadow Lea Cemeteries. D. Friesen asked C. Huff to be included in upcoming Committee meeting when discussing the Warren Cemetery specifically. L. Brown will make the request to L. Schellekens.
