Public Works Report (3rd Monday of the month only)

- > Operators hung up the Christmas lights in Warren (They repaired the burned-out lights and made use of the rest).
- ➤ Winter maintenance is in progress (Snow removal and sanding of streets and sidewalks).
- > Tree branches were trimmed above the sidewalks on Poplarwood and MacDonald as requested.
- > Speed signs (50 km/hr) were ordered and posted on Poplarwood.
- > The bridge at Hanway Park was removed and replaced by a 3-foot approach and a culvert as requested.
- Mixed sand was purchased and stockpiled for use during the winter months.

New Business

- > The LUD of Warren Committee would like the sidewalk on Hanlan cleared.
- ➤ The Poplarwood sidewalk is icy. The LUD of Warren Committee would like this sanded and salted.
- > The Committee would like the path at the Hanlan Park onto Railway cleared of snow.
- > The LUD Committee has decided against purchasing the hanger brackets from the RM for display in Warren.
- > The Committee is requesting keys to the LUD of Warren Committee Office space to be able to meet for discussions. Council will be asked if this is alright.
- ➤ High Speed Internet update: Council met with a consultant, there is a 75% grant available. The upgrade will increase the internet speed to 1000 mbps up and down. Council is looking into this.
- > 79 Poplarwood has snowmobile traffic going through their yard that they would like a solution to. L. Brown to discuss with Operations Manager and CAO.
- > Code of Conduct By-law: Elected Officials have to take the course but there are no regulations stated for LUD Committees.
