#### BY-LAW NO. 2751/22

**BEING A BY-LAW OF THE RURAL MUNICIPALITY OF WOODLANDS** to revise and update the fees payable to the Municipality for municipal services and building permits rendered under the authority of The Municipal Act, The Planning Act, The noxious Weeds Act, and the By-laws of the Municipality.

WHEREAS the council of the Rural Municipality of Woodlands deems it advisable to include in one by-law the fees and charges payable to the Municipality for certain services;

**NOW THEREFORE** the Council of the Rural Municipality of Woodlands in regular session assembled, enact as follows:

- 1) THAT Schedule "A" attached to and being part of this by-law shall become the FEE SCHEDULE of the Rural Municipality of Woodlands.
- 2) THAT By-law No. 2637/13 hereby is repealed.

#### **Section 8. Fee Surcharge**

- 8.1 The following in this section of the By-Law outlines the Fee Surcharges, which shall be deducted from the Security Deposit.
- 8.2 All fee Surcharges may be appealed to the RM of Woodlands council, if an appeal is provided in writing to council within 30 days of the written notice of the Surcharge. After considering the appeal, the RM of Woodlands council shall pass a resolution upholding, overturning, or modifying the Fee Surcharge as council sees fit.

#### **Section 9. Construction Security Deposits**

- 9.1 The following table in this section of the by-law outlines the security deposit amounts for all construction and/or renovations, which shall be paid to the RM of Woodlands by the applicant or property owner prior to the issuance of a building permit.
- 9.2 Security deposits shall be refunded in accordance with the following requirements:
  - a) The Building inspector has conducted a final inspection of the subject property and has confirmed that all construction and/or renovations have been completed pursuant to the permit and all by-laws, and that all associated documentation has been submitted to his/her satisfaction; and
  - b) The RM shall refund the security deposit to a different party if the person who paid it advises the RM in writing that it has been assigned to that other party.
