Public Forum

New Business

- ➤ The RM of Woodlands Council has asked if the LUD of Warren Committee would be interested in purchasing the banner brackets that are currently hung in town with the Grad 2020 banners. D. Friesen asked to table this to have more time to consider.
- > The Planters have been removed from Hanway Park and are being kept in the Warren Shop.
- > Asphalt patches in Warren have been completed.
- > Forster Drive the branches have been cleaned up. It looks very nice.
- The survey for the Right of Way on Hanlan is still scheduled to happen this year.
- > The LUD Committee has asked for better transparency from Council and Public Works.
- > RM of Woodlands Council has asked for input from the LUD Committee regarding a pathway at the Elementary School. The Committee agreed that there should be a path for students.
- Sewer and Water repair. an MTS line was cut. The contractor is responsible for damages.
- C. Olson asked to have keys for the LUD Office. Only paid employees of the RM of Woodlands are given keys to this. This is to be discussed further during the scheduled joint meeting with the CAO, Reeve and Operations Manager.
- ➤ There is Fibre Optic in Marquette for the Prairie Roots Co-Op. They made arrangements with the RM of St. Francis Xavier directly.
- There are still a lot of leaves that haven't fallen yet. L. Brown to enquire whether the clause stating unlimited amounts of leaves for the Month of October could be extended into November?
