- There's a new proposed internet provider in Warren. Yottabit. They indicate that they have good upload and download speeds. They're currently looking for a tower site in town.
- There is no Rec Director yet. Interviews were conducted and the position was offered. It is still unknown as to whether she will accept or not.

Public Works Report (3rd Monday of the month only)

The crack sealing was completed. It won't be possible to provide a detailed list of where the work was completed. Public Works is aware that not all cracks were done.

New Business

- L. Brown to ask the Public Works Foreman if it is at all possible to get a light arm at the Hanway Park. It is very dark at that corner.
- Christmas lighting There was to be a display this year at the Community sign but there is no power source. This will be looked at in 2022 again. L. Brown will ask Public Works to assess the existing lights to determine which ones need repairs or replacement.
- 79 Poplarwood There is an easement on this property and the ditch is eroding. Council is looking into what can be done with this.
- There is another small triangle property that was just purchased on Poplarwood. The new owners are asking if the drainage ditch that runs through the property can be filled in with a culvert. The municipality wants to have an Engineer Study done to determine what would be the best course of action for this property. The LUD Committee are asking for a Ball park dollar amount for the cost. L. Brown to ask the CAO.

- Vaccine mandate The RM is monitoring the Province closely to see what will be mandated before making any changes to the current policies.
- Donation to LIONS Park for the damaged monument. The estimated cost to replace the monument is approximately \$650.00 USD. The LUD Committee would like to make a donation towards this cost.
- The LUD of Warren Committee are looking for a definitive answer from Council regarding the boundary expansion application.
