- ➤ Ditch along road 4W between road 77N and Poplarwod. Chad explained that the ditch needs to be corrected and moved over. It is partially on the developer's property.
 - o Discussion was to wait for the feasibility study and see what is in there. It may recommend increase culvert size or reshape the ditch.
- > Street sign at poplarwood and road 4W. Chad explained that the road will be getting renamed with the new development. So better to wait until that takes place.
- ➤ Visioning workshop Cal talked about his vision for it and about talking with a 3rd party to facilitate it.
- ➤ Valley fibre discussion about the issues with the installs and the process to get the complaints in. The RM should be keeping a list of the issues so they can make sure they get corrected.
- ➤ Request to Lions RM council has approved the LUD to send a request for a donation for the lighting at the Warren Dog Park.
 - Will send request to Kaitlyn to be put on RM letterhead.
